Student Waiver & Release of Liability

Thank you for joining Class Act Dance! Please read the following waiver and policies carefully. By signing this document (electronically or physically) you acknowledge that you have read, understand and agree to comply as stated below.

RELEASE OF LIABILITY

- Dancing, stretching or performing is a physical activity.
- Class Act Dance and their instructors will be held harmless for any personal injuries; loss of or damage to personal property occurring at its place of business or at any venue where they may be rehearsing or performing.
- I acknowledge policies held by Class Act Dance which recommend doctor examinations for students, especially under 13 years of age, before participating in any activity which may cause or progress any injury or limitations the student may have; to consult with a physician before participating in any activity if I have any doubt as to my, or my child's physical abilities.
- Class Act Dance cannot dispense any medications, including aspirin or ibuprofen.

REGISTRATION FEE

- An annual registration fee of \$30.00 per student or \$45.00 per family (not extended family) is required at the time of registration once each season to reserve class space, with the exception of session-based classes. Registration is not considered complete, nor is class space reserved, until this fee is paid.
- Students registering for the first time during the Summer Session are charged a \$15 registration fee.

TUITION

1. Tuition is due on the 1st of each month and all families must have a valid credit card on file.
2. The preferred tuition payment method is auto-pay using a debit/credit card. Auto payments are processed by the 3rd of the month. Payments may also be made online or by contacting the office using a debit/credit card or with check/cash at the office.

3. If tuition is not received by the 10th of the month, payment will be processed using the card on file. Past due accounts are subject to a \$25 late fee if not brought current by the 15th of the month. This also applies to credit/debit transactions that are declined and checks that are returned.
4. By registering at Class Act Dance, you are obligating your student/yourself to ongoing instruction and participation. You are entering into a monthly obligation whether you or your student attends every class. You must inform the office in person, on the phone or with an email to withdraw your dancer from class. Tuition will not be charged for the following month as long as notification is received before the month begins.
5. No pro-rating is done except at the time of enrollment.
6. Our regular dance season is held from September through June, and tuition is based on a four week month. There are six months that have five weeks of classes. During the month of December there are only two weeks of classes so that the studio may close for a Christmas break. The studio is closed for one week of spring break and on major holidays (Memorial Day, Labor Day and Thanksgiving). The months with extra days make up for the holiday closures which will even out tuition over the season.
7. Summer Session classes must be registered for separately from the regular season and span a four week time period during the summer months.
8. 10% discount given to seniors, military families, siblings and middle/high school performing arts students. Contact the office for these discounts.
9. Any changes to enrollment MUST be communicated to the office by the first of the month. If communication is not received, tuition will be charged.
10. NO REFUNDS/CREDITS WILL BE GIVEN FOR CLASSES DROPPED MID-MONTH. There will be no refunds for missed classes. Make-ups are offered for missed classes.

DROP/ADD CLASS POLICY

- You may end your classes at Class Act Dance at any time. It is your responsibility to inform the office in person, on the phone or with an email before the new month begins. **DO NOT INFORM THE INSTRUCTOR ONLY.**
- Class additions or changes must also be communicated to the office in person, on the phone or with an email.

MAKE-UP CLASSES

- Students have 30 days to make up any missed classes. The class must be in the appropriate age and skill level of the student. Please ask the front office for suggestions for make-up classes and to schedule a make-up. Make-ups must be used by the end of the regular season and may not be carried over to the Summer Session, or from the Summer Session to the next regular season.

STUDIO POLICIES

- Please make sure your dancer arrives on time and ready to dance. To avoid injuries, dancers who arrive more than 10 minutes late will be asked to sit out and observe the class.
- When possible, let the studio know ahead of time if you will be absent.
- Please do not interrupt classes to speak with instructors. Email info@classactdance.com with any questions or concerns you may have regarding our instructors, classes or placement. Please contact the office to make an appointment if you need to speak with the instructor.
- Students must be picked up from the end of class on time. Class Act Dance is not responsible for watching your child after the dance class ends or leaving a sibling unattended during the class.
- Class Act Dance reserves the right to cancel classes due to low enrollment. Refunds will be provided for students who have prepaid for any canceled class.
- Lost & Found boxes are located in the changing room. Unclaimed items left in the basket will be donated to a local charity throughout the course of the year.

ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS / COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Class Act Dance & Performing Arts Studio (CAD) has put in place preventative measures to reduce the spread of COVID-19; however, CAD cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending activities at CAD's facilities could increase your risk and your child(ren)'s risk of contracting COVID-19. Due to the nature of the activities, there may be times when incidental contact may occur. Direct physical assistance will also be provided in the event of an injury. By signing this agreement, I acknowledge and agree that incidental contact may occur, and I agree to permit my child(ren)'s teacher to physically assist my child(ren) if needed.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending activities at CAD's facilities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand the risk of becoming exposed to or infected by COVID-19 at CAD's facilities or while participating in CAD programs may result from the actions, omissions or negligence of myself and others, including without limitation CAD employees, program participants and their families.

AGREEMENT TO COMPLY WITH POLICIES RELATING TO CORONAVIRUS / COVID-19

Class Act Dance & Performing Arts Studio ("CAD") has put in place preventative measures to reduce the spread of COVID-19 and it is important that all of our parents and families comply with CAD's policies and do their part to help maintain a safe and healthy environment at CAD's facilities. These measures are subject to change in accordance with government guidelines.

By signing this agreement, I acknowledge that my actions as a parent or legal guardian will also impact the safety of all others in the CAD facilities. CAD is counting on our families to help meet the physical-distancing and personal hygiene standards recommended by the CDC, the State of California and the County of San Luis Obispo. As such, I agree to abide by the following policies, as well as any additional policies that may be adopted by CAD from time to time:

1. We need to limit in-person viewing because our seating will need to be decreased to conform to the 6' distancing standards. We ask that only parents of dancers six and under wait in the lobby areas and all others to drop dancers off. Masks may be required and temperatures taken at all entrances.
2. We urge our students to wash their hands frequently and certainly before and after class. We will also provide hand sanitizer at stations throughout the studios.
3. Our class and practice schedule will change to allow for fewer children entering and exiting the building at the same time. We will have staff available to direct kids to find their class and also to get outside to their parents as needed.
4. Please do not bring your child or yourself if either of you has a fever or are not feeling well.
